Sandra Courtman is Senior Lecturer at the Institute of Education, University of Sheffield. She has edited *Beyond the Blood, the Beach and the Banana: New Perspectives in Caribbean Studies* (2004) and Joyce Gladwell's *Brown Face Big Master* for the Macmillan Caribbean Classics Series (2003). Her research activities and publications are particularly concerned with recovering 'lost' and occluded Caribbean women's writing from the 1960s and 1970s.

Alison Donnell is Senior Lecturer in Postcolonial Literatures at Nottingham Trent University. She has edited *Companion to Contemporary Black British Culture* (2002) and co-edited *The Routledge Reader in Caribbean Literature* (1996) and *Representing Lives: Women and Autobiography* (2000).
